Foreword

Crimes are a daily occurrence in Sierra Leone, which tend to disturb the security of the state if mechanisms are not properly implemented to curtail it. Without an effective Police Force, the wider state, society and the economy would be challenged in terms of functioning effectively and maximally. Today, challenges to policing Sierra Leone include rapid urbanization, population growth, rising inequality, unemployment and mass migration to the urban areas which give rise to a huge range of criminal challenges including Robbery, Corruption, Domestic Violence, Fraud and other offences. Although specialized bodies exist to deal with some of these, the primary agency in the frontline of addressing these challenges is the Sierra Leone Police Force.

As Inspector General of Police, I implore the public, state actors and colleagues in the security sector to join forces together to fight the menace of crime in our beloved country thereby making it peaceful for communities to live in and contribute to national development. EXECUTIVE SUMMARY

On account of the fact that the onus of providing safety and security rests primarily on the Sierra Leone Police, working with partners, and reporting on crime is an integral part of police activities, members of the public need to be regularly updated on the trend of crimes, their hotspots (where crimes are prevalent), and the occurrence and locations of major offences committed. Every year, Sierra Leone Police publishes a report showing crime trends nationwide, that is, crimes reported in all police formations throughout the country, from January to December.

This year's crime report does not only analyze crime by regions, but it also gives detailed analysis of crimes by policing divisions.

The reasons for this are:

- To determine regions with the highest number of criminal activities
- To determine divisions with the highest major criminal activities
- To be able to allocate resources to the more affected regions and divisions

Findings:

In 2022 Crime year, **27,018** criminal activities were reported in all the six (6) Police Command Regions in Sierra Leone. However, the Criminal Investigations Departments (CID) Headquarters in Freetown alone received and investigated **2,015** Criminal Cases.

Traffic Department received and investigated **4,124** Road Traffic Accidents cases in 2022.

In total, 33,157 Criminal and Accidents cases were reported and investigated by the Sierra Leone Police Countrywide with an overall crime rate of 0.39% and in 2021, there were 41,459 criminal cases reported with a crime rate of 0.50%. There was a tremendous decreased on the rate of Crimes by 11% in 2022.

For the past years, there had been sharp reduction in the number of crimes in Sierra Leone which has actually contributed to the stable environment in the country.

Reasons for these remarkable declines are:

- Strong security measures taken by Police and the RSLAF Could be one of the greatest factors responsible for these declines (joints day and night patrols by Police and RSLAF, mounting of check points at Strategic points at night, timely response to distress calls etc.)
- Community sensitizations on crime prevention
- Continuous stakeholders engagement on crime prevention strategies

Regional Crime Rate

The essence of analyzing crimes on regional basis is to know which, among the Six (6) Regional Police Commands in Sierra Leone, are prone to criminal activities and the offences that are mostly in play, so that Senior Police Management and other key players in crime management can find possible ways of reducing its effects on communities.

The Annual Crime Statistics Report 2022 indicates that, Western Area (Freetown East and West) recorded **21,222** criminal cases representing **1.18%**, Northern Region (North West and East) received **4,795** criminal cases with a percentage of **0.16%**, Southern Region recorded **3,533** criminal cases representing **0.20%** and Eastern Region recorded **3,587** criminal cases which represent **0.18%**.

From the Regional analysis above, there is a clear indication that Western Area is prone to more criminal activities than any other region in Sierra Leone, followed by Southern Region, Eastern Region and Northern Region, respectively.

Divisional Crime Analysis

In Sierra Leone, we have six (6) Regional Police Commands and these regions are further divided into thirty-six (36) policing Divisions. These Divisions are being manned and controlled by the Local Unit Commanders (LUCs). In as much as crimes have been analyzed regionally, it is also equally very much important to know Divisions that are crime threats so that modalities can be fully put in place to help those Local Unit Commanders in the affected divisions to curtail the criminal activities in their divisions.

The Annual Crime Statistics Report 2022 identifies three (3) major offences that are prevalent in certain divisions, which are **ROBBERY WITH VIOLENCE**, **ROBBERY WITH AGGRAVATION AND MURDER**.

Divisional Robbery Cases

In this analysis, it is established that Lumley Division which falls under Freetown West Region recorded the highest number of cases of Robbery with Aggravation with **54** cases and Robbery with Violence with **31** reported cases, Goderich recorded **8** cases of Robbery with Aggravation and Congo Cross recorded **7** cases. Bo West in the Southern Region recorded **21** cases of Robbery with Aggravation and **15** cases of Robbery with Violence, Harbour Division recorded **24** cases of Robbery with Aggravation and **15** cases of Robbery with Violence.

The above divisions are prone to robbery incidents than any other divisions in the six (6) Regional Police Commands in Sierra Leone.

Divisional Murder Cases (HOMICIDE)

In the Freetown-West Region, the Criminal Investigations Department (CID-HQ) received and investigated **81** murder cases, Central Division also received and investigated **8** murder cases, Goderich Division investigated **6** cases, Lumley and Congo Cross Divisions **5** cases each.

In the Freetown East, the Harbour Division received **9** murder cases, Kissy Division also received **9** cases of murder, Waterloo Division recorded **6** cases and Eastern Police Division received **6** cases of murder.

North East Region, Magburaka received and investigated the highest number of murder with 11 cases, Kabala and Mile 91 Divisions recorded equal number of 4 cases each.

In the North West Region, Kambia investigated 4 murder cases, Lungi and Lunsar Divisions recorded 3 cases each Bo West, in the Southern Region received and investigated 22 murder cases. And in the Eastern Region, 16 cases of murder were in Kenema division and 4 cases of murder in Kailahun division. From the above, it was cleared that in 2022 crime year, Freetown West Region police received and investigated the highest number of murder cases, that means, unlawful killing of persons were at the peak in Freetown West followed by Freetown East, North East, Eastern region, Southern region accordingly and North West region received and investigated the least number of murder cases.

- Provision of a dedicated communication system for the SLP (HF & VHF Radio sets) so as to ensure real-time information dissemination in a bid to improve on SLP response time.

Crime Index (Crime per 100,00 people)

Western Area (Freetown East&West) recorded the maximum crime index of **1,183** per **100,000** person followed by Southern Region **204** cases, Eastern Region with **181** cases and Northern Region (North East&West) **159** cases.

Brief facts Analysis

From the analysis, there were **33,157** Criminal and Accident Cases reported in 2022, out of these reported cases, Offences Against Women and Children were the most committed offences with **11,613** cases followed by Offences Against Property with **8,043**, Offences Against Persons with **4,691** cases, Road Traffic Accidents **4,124** cases, Economic Offences **3,655** cases, Public Order Offences with **898** cases and Miscellaneous Offences with **133** cases.

In 2022, Family Support Unit (FSU) received and investigated 11,613 cases as compared to 11,815 cases in 2021. Out of these reported cases, there were 8,899 Domestics Violence cases, 483 Offences involving children and 2,231 Sexual Offences.

Regional Analysis of Sexual Offences

From the Sexual Offences, **2,001** Sexual Penetration of a child cases were reported. From these figures, **Eastern Region** investigated **490** cases, **103** cases were charged to Court, **11** cases closed, **15** cases kept in view and **361** cases still under investigations. Also **1** case of Sexual Harassment was recorded and kept in view and with **13** cases of Rape, of which **1** case was sent to court, **1** case closed and **11** cases under investigation.

Freetown East received and investigated 453 cases of Sexual Penetration of a child. Out of these, none was charged to court, 1 case closed, 18 kept in view and 434 still under investigations. For Sexual Harassment, 8 cases were investigated, out of the 8 cases, 6 cases are under investigations and 2 cases kept in view. There were 12 cases of Rape were recorded and are still under investigations.

Freetown West Region received and investigated 345 cases of Sexual penetration of a Child, none of these cases charged to court, 1 case closed, 5 cases kept in view and 339 cases under investigations. There were 13 cases of Rape recorded and still under investigation and 11 cases of Sexual Harassment of which 10 cases are under active investigations and 1 case closed.

North East Region received and investigated 303 cases of Sexual Penetration of a child, from these figures, 12 cases were charged to court, 15 kept in view and 276 still under investigation. For Rape, 29 cases were received, 1 case was charged to court, 2 cases kept in view and 26 cases under investigation and 2 cases of Sexual Harassment were recorded.

North West Region also received and investigated 93 cases of Sexual Penetration of a child. 7 cases charged to court, 1 case closed, 8 cases kept in view and 77 cases under investigation. 1 case of Rape was report and still under investigation and 3 cases of Sexual Harassment under investigation.

Southern Region received and investigated **317** cases of Sexual Penetration of a Child, out of these, **37** cases were charged to court, **2** cases closed, **2** cases kept in view and **276** cases under investigations.

There were $\bf 4$ cases of Sexual Harassment recorded and are still under investigations and of the $\bf 10$ cases of Rape recorded, $\bf 3$ cases are charged to court, $\bf 1$ kept in view and $\bf 6$ cases under investigation.

There is 1 case of Sexual Exploitation recorded in the Southern Region in 2022.

What is worth noting in the above analysis is that, Eastern Region investigated and sent the highest number of Sexual Penetration cases to court, compared to the other Regions.

Regional Analysis of Domestics Violence Cases

Out of the **8,899** Domestic Violence cases reported, **Eastern Region** received and investigated **1,411** cases. **159** out of these cases were charged to court, **350** cases closed, **147** kept in view and **755** under investigation.

Freetown East Region investigated a total of 3,385 Domestic Violence cases, 54 cases out of these were processed and sent to court, 448 cases closed, 533 cases kept in view and 2,350 cases still under investigation.

Freetown West Region also investigated 1,507 Domestic Violence cases, 4 cases of which were sent to court, 135 cases closed, and 190 kept in view and 1,178 cases under investigation.

North East Region recorded 1,229 Domestic Violence cases, of which 145 were sent to court, 219 closed, 214 kept in view and 651 under investigation.

North West Region recorded 421 Domestic Violence Cases. 49 cases from these figures were sent to court, 74 cases closed, 109 cases kept in view and 189 cases under investigation.

Southern Region investigated **946** cases. **117** cases were sent to court, **126** cases closed, **61** cases kept in view and **642** cases still under investigation.

Eastern Region sent the highest numbers of Domestic Violence cases to court followed by North East and Southern region respectively.

Regional Analysis of Child Offences

Family Support Unit of the Sierra Leone Police recorded **483** cases of Offences involving children. From these figures, **Eastern Region** investigated **33** cases, **2** cases sent to court, **3** cases closed, **6** kept in view and **22** under investigation.

Freetown East recorded 224 cases of Offences against Children; 48 cases of that were closed, 31 kept in view and 145 cases still under investigation.

Freetown west recorded 144 cases; 22 cases were closed, 21 cases kept in view and 101 cases still under investigation.

North East received 27 cases of Offences against Children; 6 cases of that were closed, 1 case kept in view and 20 still under investigation.

North West recorded 18 cases of Offences against Children; 2 cases sent to court, 4 closed, 4 kept in view and 8 cases still under investigation.

Southern Region received **37** cases; **2** cases sent to court, **7** cases were closed **3** cases kept in view and **25** cases under investigation.

From the above, South, North West, and Eastern Region investigated and sent cases of this nature to the courts.

collating and analyzing information and disseminating criminal intelligence in relation to transnational crime and drug trafficking; proactively develop targets for investigation of complex transnational organized crime cases. This Unit is being supervised by the Director of Crime Services and it investigated 199 cases in 2022 as compared to 117 cases in 2021.

13.0 LEGALAND JUSTICE SUPPORT DEPARTMENT

This Department also falls within the Directorate of Crime Services of the Sierra Leone Police. The primary functions of Legal and Justice Support Department are certification of case and enquiry files, proffer appropriate charges and prosecute all criminal matters in the Magistrate Courts of Sierra Leone. In 2022, a total of 6,591 cases were received and prosecuted by Legal and Justice Support Department. From this figure, 1,279 cases were discharged, 73 cases acquitted and discharged, 562 cases cautioned and discharged, 2,781 cases sentenced and fined and 627 committed to the High Courts, whilst there remains 1,266 existing files.

14.0 SIERRA LEONE POLICE CRIME MANAGEMENT STRATEGIES

Crime Management Strategies in the Sierra Leone Police are mechanisms implemented by the Police to combat the rate of crime. Below are the strategies:

- · Mobile Vehicle Checkpoints at Strategic Locations
- · Local Policing Partnership Boards (LPPBs).
- · Intelligence-Led Policing
- · Community Safety Volunteers (CSVs)
- The use of 112 Emergency Toll Free Line
- · Community Sensitization on Crime Prevention Strategies.

15.0 CHALLENGES

- · Late submission of Monthly Crime Statistics to the Corporate Affairs Directorate by Commanders.
- Lack of training for Data Analyst and Data Officers in the various regions.

16.0 RECOMMENDATIONS

Since the Intelligence- Led Policing and Community Policing Initiatives are the reasons for the drop in the rate of crime in Sierra Leone, the following recommendations are made:

- To intensify intelligence gathering efforts in order to identify high profile criminals and their hideouts.
- To deploy Community Safety Volunteers (CSVs) and coordinate well with the Local Policing Partnership Board (LPPB) members.
- The Family Support Unit (FSU) and the Ministry of Social Welfare, Gender and Children's Affairs should team up and organize sensitization meetings to educate students/ pupils on Sexual Penetration and Rape and how to deal with them.
- The political will to foster the reporting of rape incidents countrywide should be enhanced.
- Establishment of accessible roads on hilltop and sea front areas. Most of the major crimes like armed robbery are committed in places where vehicles cannot access due to the poor road network. To ensure timely response to these incidents, the Sierra Leone Roads Authority (SLRA) should

11.0 NATIONAL CRIME BUREAU (NCB INTERPOL) FREETOWN

INTERPOL is an international organization that facilitates worldwide police cooperation and crime control. It is the world's largest international police organization. It further enhances mutual aid and cooperation among the police forces of its national members in order to prevent and inhibit crime. This unit falls under the Directorate of Crime Services. This Unit investigated and prosecuted a total of 1 case nationwide in 2022 as compared to 4 cases in 2021.

12.0 TRANSNATIONAL ORGANIZED CRIME UNIT (TOCU) IN SIERRA LEONE.

The Transnational Organized Crime Unit in Sierra Leone has the responsibilities of collecting,

In the area of Traffic Management, a total of **4,124** Accident cases were reported and investigated by the police countrywide as compared to **4,156** cases in 2021. From the analysis, we noticed that there was a slight decrease of **32** cases in the number of accidents reported cases in 2022.

The Annual Crime Statistics Report 2022 from Traffic indicates that, there were **360** persons fatally injured. From these figures, **269** were male and **91** were female. For seriously injured, there were **1,083** persons of whom **695** were male and **388** were female. Similarly, **2,511** persons were reported to be slightly injured of which **1,550** were male and **961** were female.

From these accidents, **2,652** cases were charged, **2,326** cases gained convictions and fined Le **944,890,000** in the old currency.

The Transnational Organized Crime Unit (TOCU) investigated a total of **199** cases; of which **81** cases were charged, **8** cases sent to DPP, and **109** cases under investigation. Comparatively, TOCU investigated lesser number of cases in 2022 than in 2021 with **115** cases.

The National Crime Bureau (NCB) Interpol Freetown investigated 1 case of Fraudulent Conversion as compared to 4 cases investigated in 2021.

Cyber Crime Unit investigated **738** cases in 2022; of which **39** cases were charged to court, **110** sent to the Director of Public Prosecutions (DPP) for advice, **78** cases were closed, **366** cases kept in view and **145** cases under investigation.


Anti-Fraud Unit also investigated 115 fraud-related cases in 2022; 24 of these were charged to court, 6 cases sent to the Director of Public Prosecutions for advice, 7 cases were closed, 6 cases were kept in view and 72 cases still under investigation.

In total, there were **33,157** reported cases nationwide and out of these reported cases, **6,591** cases **(20%)** were received and sent to court by the Legal and Justice Support Department of the Sierra Leone Police. Out of these figures that were sent to court, **2,781** gained convictions/sentenced, **627** cases were committed to the High Courts, **562** cases cautioned and discharged, **73** acquitted and discharged, **1,279** cases discharged and **3** cases nullified by the Director of Public Prosecutions.




Figure 16: Freetown West Anti Land-Grabbing reported cases

10.0 CDIID CRIME STATISTICS IN 2022

The Complaint, Discipline and Internal Investigations Department (CDIID) is a department tasked with maintaining discipline in the Sierra Leone Police and the investigation of police wrongdoing (wrongdoing/excesses). This department is supervised by the Director of Professional Standards who carries the rank of an Assistant Inspector General of Police (AIG). This department receives complaints from members of the public against police personnel and also investigates matters that arise among serving personnel. In 2022, this department investigated 897 Disciplinary Offences.

8.0 LARCENY CATTLE CASES

If any person shall feloniously take livestock belonging to another, either without the consent of the other to the taking, or by means of fraudulent conduct, practices or representation, he shall be guilty of larceny cattle.




Figure 14: Regional comparison of Cattle theft/Larceny in 2022

9.0 Anti-Land Grabbing Unit

Land grabbing is an activity by which someone occupies or attempt to occupy any land over which she/he does not have any lawful entitlement.

Conflicts over land increase every year in Sierra Leone, fueled by large-scale investments in Land. There were 1,027 cases of Land Grabbing received and investigated by Anti-Land Grabbing Units for both Freetown East and West Regions. Freetown East region received and investigated 808 Land related cases in 2022. From these figures, 200 cases were sent to court, 500 sent to Ministry of Lands for expert opinion and 308 still under investigation.

Freetown West Region also received and investigated 219 land grabbing cases. Out of these figures, 25 cases were sent to court, 56 cases sent to the Ministry of Lands for expert opinion and 138 still under investigation.

The graph above indicates that the highest number of murder cases occurred in the North East Region with 20.97 percent. The Second was the Freetown East Region with 18.95 percent. The Eastern Region had 18.3 percent of murder cases reported. The prevalence of murder cases in all the six Regions in the country is worthy of note.

6.0 ASSAULT ON POLICE

It is a crime to assault a police officer or other public safety first responders while they are performing their official duties. Police officers face molestation and get assaulted by lawless individuals while executing their lawful duties across the nation. In 2022, Sierra Leone Police (SLP) recorded 94 cases of Assault on Police across the Six (6) Regional Police Commands in Sierra Leone. Below is the table showing breakdown of cases in the six (6) Regional Police Commands.

It could be observed from the table that the Western Area (Freetown East and West) recorded 60 cases of Assault on Police Officers, whilst they were performing their legal duties as the Constitution demands, 18 Police Officers in the South and 11 Police Officers assaulted in the North East region.

7.0 ASSAULT CASES

Assault can be closely defined as a violent crime in which an individual or a group inflicts physical contact that causes bodily harm and/or injury to another individual. Sierra Leone Police received and investigated 2,329 Assault cases countrywide.

The table below clearly shows figures of Assault Cases that occurred in the six Regions in Sierra Leone.




Figure 12: Regional Percentage of Robbery with Violence Cases




Figure 13: Regional Percentage of Murder Cases in 2022

1.0 INTRODUCTION

Sierra Leone Police among its various mandates is to ensure that, the public is fully informed about the crime situations through the yearly production of the general crime statistics report.

Information on crime that is accurate, reliable, timely and accessible enhances conversation about policy and helps protect the people we serve by implementing crime prevention strategies, whist crime patterns and trends could be easily identified and analyzed in order to mitigate the recurrence of same.

Such information advises Management in making decisions on the allocation of resources and helps provide information to the public on some perceived misconceptions on the nature and scope of crime in Sierra Leone.

1.1 Comparative analysis of Crime for 2021 and 2022

The table below shows the amount of cases reported in 2021 and 2022 (41,459 to 33,271).

Similarly, a total of 33,157 cases were reported in 2022 at a projected population of 8,494, 260, giving a crime rate of 0.39%. From the table above, there was overwhelming reduction of crime by 11% in 2022 as compared to 0.28% in 2021.




Figure 1. Showing Comparison of Regional Crime Rates for 2021 and 2022




Figure 11: Showing Regional Percentage of Robbery with Aggravation in 2022

In 2022, a total of 111 cases of this offence were recorded compared to 97 cases in 2021. Below is the table showing a breakdown of Robbery with Violence cases in the Six (6) Police Regions.




Figure 10: Comparison of Regional Sexual Penetration of a child, Rape and Domestic Violence.

4.0 ROBBERY CASES

Robbery is the taking of another's property by force or threat; this is sometimes also referred to as Larceny by Threat or Force. On account of the fact that robbery involves injury or threat of injury, it is considered a more serious crime than many of the other theft crimes. For the annual Crime Statistics of 2022, Sierra Leone Police (SLP) focuses on two main types of Robbery for analytical purposes:

- (i) Aggravated Robbery
- (ii) Robbery with Violence

4.1 Robbery with Aggravation

This is the taking of the personal property of another through the use of force or threat of imminent force while implying that, the perpetrator has a firearm or other dangerous weapon including a knife, bludgeon, axe or other deadly implement. In 2022, 167 Robbery with Aggravation incidents were recorded as compared to 180 cases in 2021. The table below clearly shows the number and percentage of Robbery with Aggravation cases that occurred in each Region.

From the above table, there were 167 cases of Robbery with Aggravation in 2022. The table clearly indicates that, Freetown West received and investigated 85 cases representing 50.89% followed by Freetown East with 34 cases or 20.35%. The rate of Robbery with Aggravation is higher in Freetown West than the other Regions in Sierra Leone, followed by Freetown East and Southern region, respectively

The table above shows offences committed by regions in 2022 and clearly indicated as well regions with the highest numbers of criminal activities

The table shows that Freetown East investigated the highest numbers of criminal activities with 10,715 cases. That is, Freetown East in the Western Area is more prone to criminal activities than the other regions.

However, Freetown West in the same Western Area recorded the second highest cases with 10,507. Western Area particularly is exposed to criminal activities as compared to the four (4) regions in the provinces. People on daily basis migrate from the rural to the urban areas in search of a better life, partly because decentralization of Government institutions and resources and the availability of job opportunities are yet to be fully actualized. This has contributed to increased criminal activities in urban settings, making the cities unsafe.

North West Region recorded the least numbers of criminal activities with 1,775 cases in 2022. Details of the other regions can be seen on the table above.




Figure 2: Showing number of cases reported at the six police regions in Sierra Leone Table 4: categories of offences by regions in 2022

1.4 Offences against Women and Children at Regional Level

Offences against Women and Children are the most committed in Sierra Leone.

Sierra Leone, across the six regions received and investigated offences related to women and children. These offences are being categorized into three segments, which are:

- 1. Sexual offences: Under these offences we have, sexual penetration, rape, bestiality, sexual exploitation, sexual touching, meeting a child for sexual purpose, to name a few. These offences are mostly committed against vulnerable women in society. The Hands off Our Girls project might have contributed to the decline of sexual penetration cases. Sixty (60) percent of sexual penetration cases were sent to court and convictions made in 2022.
- 2. Domestic Violence: these offences are mostly committed against women by their husbands/partners at home. Offences in this category include physical torture/physical abuse, economic abuse and psychological abuse.
- 3. Offences against Children: These are offences committed against children like child cruelty, neglect of a child, child exploitation and many more.




Figure 3: showing Regional distribution of Offences against Women and Children

The table above clearly shows that, a totaled of 11,613 Offences against Women and Children were recorded, nationwide in 2022, as against 11,815 cases in 2021. From the table, 4,137 cases were recorded in the Freetown East Region followed by Freetown West with 2,052 cases. North West Region recorded less than 1,000 cases in 2022. Women and children in the Western area are more exposed to these offences than those in the other Regions.

The table above indicates that, 2,001 cases of Sexual Penetration were reported countrywide, to the Family Support Unit. From these figures, Freetown East received and investigated 3,850 cases, followed closely by Eastern region with 1,914 and Freetown West with 1,865 cases. The least cases of Sexual Penetration occurred in the North West Region in 2022

There were 78 cases reported for rape. North East recorded the highest number of rape cases; 29 cases in total. That was followed by Eastern Region with 13 cases. The least number was reported in the North West region with 1 case only

There were 8,899 Domestic Violence cases reported; 3,385 were reported at the North East region, followed by Freetown with 1,507 cases and Eastern Region with 1,411 cases. Details are found on the above table.




Figure 8: Breakdown of Public Order Offences at Regional Level

2.0 Miscellaneous Offences at Regional Level

Offences under this category include evading custom, defamatory libel, missing documents and perjury. Against this backdrop, 133 cases of these offences were recorded nationwide in 2022. Out of these figures, Freetown West recorded 87 cases followed by Freetown East with 14 cases and the least number of cases were recorded in the North East Region with 2 cases. 


Figure 9: Miscellaneous Offences at Regional Level

3.0 FAMILY SUPPORT UNIT (FSU)

Sierra Leone Police has various specialized units, among which, is the Family Support Unit (FSU) that falls directly under the purview of Crime Services Directorate. This Unit is being headed by a female Commissioner of Police. This Unit is specifically focused on investigating all forms of child abuse and violence against children and more so, investigates domestic violence matters facing mostly women in our society.

1.5 Offences against Property at Regional Level

These are offences committed against property. These offences are considered to be felonious in nature Such as Robbery with aggravation, Robbery with violence, House breaking and Larceny, Burglary and Larceny, Malicious Damaged, Arson and Destroying growing plant etc.




Figure 4: showing Breakdown of Offences against Property in 2022

From the graph above, it was clear that in 2022, Freetown West recorded the highest number of these offences followed by Freetown East region. The least reported cases came from North West region. Southern region emerged third on the graph. Property offences mostly occurred in bigger cities as clearly stated on this graph.

1.6 Offences Against the Person at Regional Level

Offences against the Person are the most committed offences in Sierra Leone. They involve direct physical harm or force being applied to another person. These offences include Assault, Murder, Causing grievous bodily harm, Wounding and Wounding with Intent.




Figure 5: showing Regional Breakdown of Offences against the Persons

From the graph, there were 1,487 cases reported at Freetown East. That is, Freetown East recorded the highest number of cases, closely followed by Freetown West with 1,297 cases. The region on the graph with the least figures is North West region. Details can be seen on the graph.

1.7 Economic Offences at Regional Level

Economic Offences are the type of Criminal offences which alter the financial status of a country no matter how much wealth that nation has. In 2022, there were 3,655 cases recorded as Economic Offences in Sierra Leone.

From the graph above, Freetown West in the Western Area recorded the highest numbers of these offences with 1,654 cases, followed by Freetown East in the same Western Area with 1,199 cases. Economic offences from this graph indicate that, it mostly occurred in Western area than any other Region in Sierra Leone. North West Region recorded the least of these offences. Details on the graph above.

1.8 Road Traffic/Crashes at Regional Level

The Traffic Management Unit of the Sierra Leone Police is charged with the responsibilities of ensuring the free flow of traffic and the safety of pedestrians on the road. This Unit regularly provides statistics of road accident/crashes, the numbers of persons involved in such accidents and the nature of injuries sustained. A total of 4,124 accidents/crashes/ collisions were recorded in 2022. Three (3) factors were attributed to the crashes; human, mechanical and environmental factors.

From the above table, a total of 4,124Traffic Management and Road accidents cases were reported nationwide. From the above analysis, 3,948 persons were involved in Road accidents. From this figure, 360 people were fatally injured (lost their lives) and among these fatally injured, 269 were males and 91 females. Furthermore, 1,083 persons were seriously injured and among this figure, 695 were males and 388 females. For the slightly injured, we had 2,511 persons; 1,550 males and 961 females.




Figure 7: Regional Breakdown of Road Accident Cases in 2022

The above graph shows Accident Cases by Region in 2022. According to the graph, 1,930 accident cases occurred in the Freetown East Region followed by Freetown West Region with 1,514 cases. 1.9 Mischief and Public Order Offences at Regional Level

There are several offences that can be grouped as Public Order Offences. As the term suggests, these are offences that are about keeping the good order in the communities. The offences are typically not serious in nature; however, most of them do still carry a term of imprisonment as a possible penalty. The most common public order offences are offensive language, misconduct, willful and obscene exposure and affray.
